



Digital Image Permission Form

'On The Edge' Fusion Youth Orchestra may take photographic prints and digital images, video recording of the young people engaged in their activities. With permission from parents/guardians and young people themselves, these images/recordings may be used to promote 'On The Edge' activities in printed and online publicity material by 'On The Edge' and its partner organisations. Please be aware that 'On The Edge' has strict child protection policies on the use of photographic and digital images. Personal information about young people, such as addresses, will never be included. In most cases names will not be used; young people will be referred to simply as 'On The Edge' members/volunteers. Full names will only be used in specific circumstances, for example, where a young person is the winner of a competition or has written an article for the '*On The Edge*' website or is interviewed on video.
